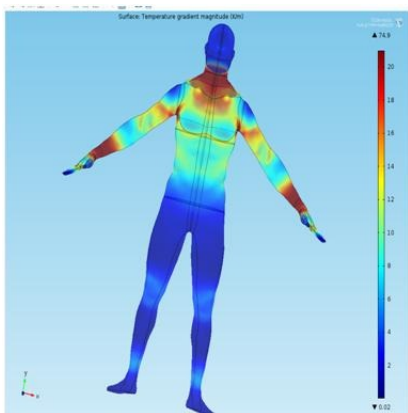


Figure 1: Temperature gradient in human body.

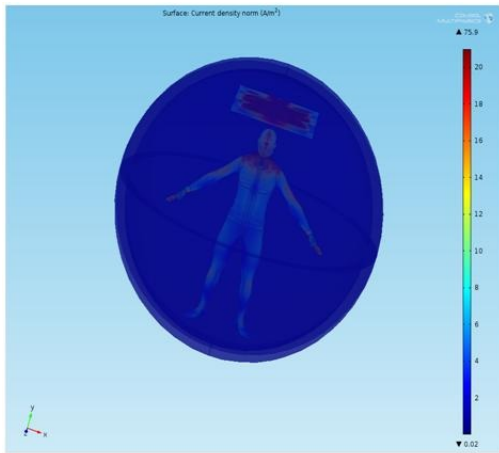


Figure 2: Current density in human body.

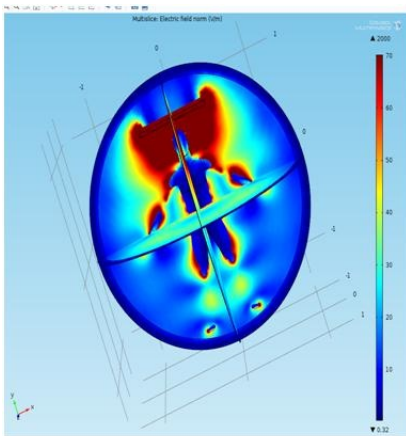


Figure 3: Electric field in human body.

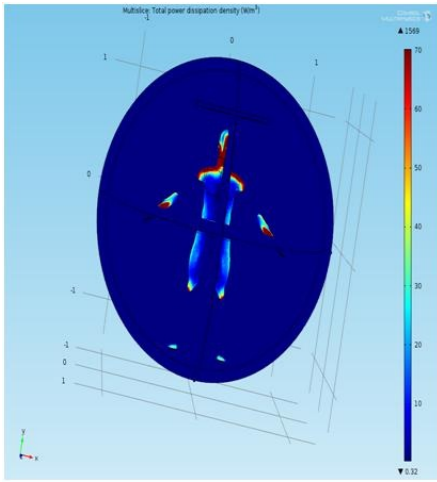


Figure 4: Power dissipation density.
